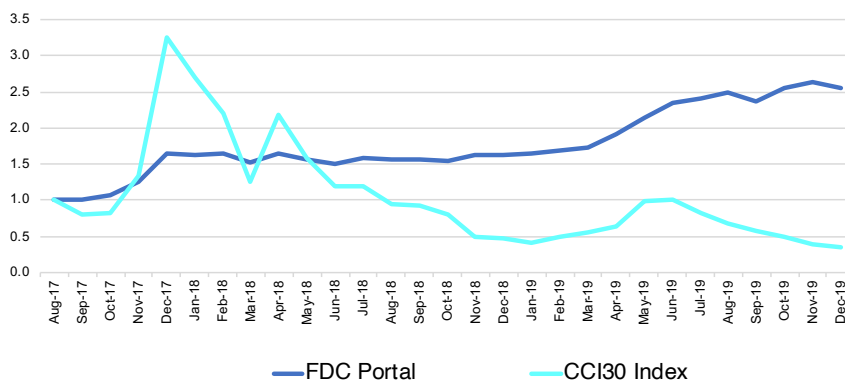
Description

The Fund's targeted returns are 25% p.a. over a rolling 5-year period net of fees.

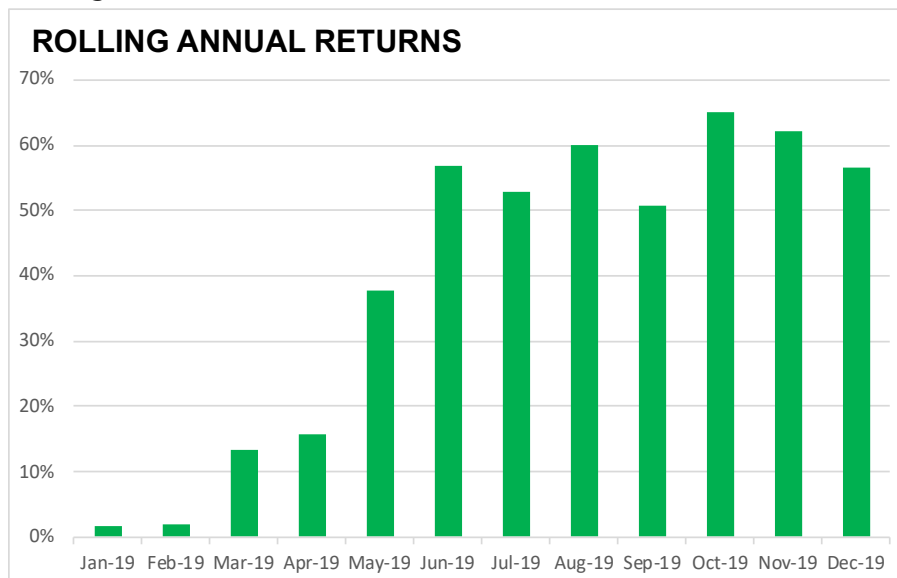
